## WVBO'S "PODS & PARTY PROPS" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WVBO-FM ("Station"), 491 South Washburn Street, STE 400, Oshkosh, WI 54904, during available business hours Monday through Friday, on the Station website www.1039wvbo.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WVBO's "PODS & Party Props"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 60 Days or a prize valued at \$500 or more in the last six months, and whose immediate family members or household members have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the six months Void where prohibited by law. On-Air: Listen to the Station weekdays during the Contest Period 6:00am CT April 27, 2024 through 5:00pm CT on May 7, 2024. When the Station plays the "cue-to-call" sounder, listeners must call the Station at 888-400-1039. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. All On-Air qualifiers will be added to the May 8. 2024 through May 17 Text qualifiers for a chance to win the grand prize. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

<u>Text</u>: Send a text message with the announced keyword spelled correctly to 888-400-1039 during the Contest Period of May 8, 2024 through May 17, 2024. All text entries from the text contest at 8:00am must be received by 9:00am CT on each contest day. All entries from the text contest at 1:00pm must be received by 2:00pm CT on each contest day. All text entries from the text contest at 5:00pm must be received by 6:00pm CT on each contest day to be eligible for a chance to win a prize. **Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text** 

messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

**Text Qualifier Selection.** On or about 9:01am CT, 2:01pm CT, & 6:01pm CT each weekday during the Contest Period, Station will select one (1) daily qualifiers, during each contest window, in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize. Then, on or about 7:01am CT on Monday, May 20, 2024, Station will select one (1) potential winner in a random drawing from among all valid daily qualifiers as selected by Station during the Contest Period.

- 4. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. The ARV of the grand prize is one thousand eighty dollars (\$1,080).
