CUMULUS RADIO'S "CHEAP TRICK & ROCK AND ROLL HALL OF FAME TOUR FLYAWAY" SWEEPSTAKES OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of any of the participating radio stations set forth below ("Stations"), owned and operated by Cumulus Media Holdings Inc. ("Sponsor"), during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to Sponsor at address below.

The Station will conduct the **Cumulus Radio's "Cheap Trick & Rock and Roll Hall of Fame Tour Flyaway" Sweepstakes** (the "Sweepstakes") substantially as described in these rules, and by participating, each participant agrees as follows:

All entries must be received by 11:59 pm ET on April 8th, 2016 to be eligible for the grand prize drawing. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Sponsor assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Sponsor. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected entries, all of which will be disqualified. In the event of a dispute as to any entry, the authorized account holder of the telephone number used to register will be deemed to be the participant. The "authorized account holder. All entries become the sole and exclusive property of Sponsor and will not be returned. No mail-in entries will be accepted.

Failure to respond to the initial verification contact within 24 hours of notification will result in disqualification.

A winner who returns the affidavit of eligibility and liability/publicity release within the required time period will be deemed to have accepted the prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. Winner's guest must be eighteen (18) years of age or older. Grand Prize Trip is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion.

8. Entry Conditions and Release.
