

“School Photo Selfie” 2016 Photo Contest

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE FOLLOWING CONTEST IS VALID ONLY IN THE (50) UNITED STATES AND DISTRICT OF COLUMBIA (D.C.), AND IS OPEN ONLY TO QUALIFIED PERSONS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED. DO NOT PARTICIPATE IN THE CONTEST IF YOU DO NOT FALL WITHIN THE ELIGIBILITY REQUIREMENTS AS SET FORTH BELOW.

Contest Name: “School Photo Selfie” 2016 Photo Contest (the “Contest”).

Contest Dates: Contest registration and photo submission begins at 12:00:00am Eastern Time (ET) on **July 25, 2016** and ends at 11:59:59pm ET on **September 4, 2016** (the “Registration and Photo Submission Period”). Contest is subject to all applicable federal, state and local laws and regulations. Void outside the (50) U.S. and D.C., and wherever prohibited or restricted by law.

Who may Enter: Contest is open only to legal residents of the (50) U.S. and D.C. who reside within the broadcast listening area of a participating Cumulus radio station, who are age 13 or older as of date of entry (entrants 18 or older must have a valid U.S. driver’s license or government issued ID), except the following persons who are not eligible to enter or win:

- (a) Employees, officers, and directors of **Cumulus Media** (the “Operator/Stations”), **Million Dollar Media, LLC** (the “Contest Administrator”), other participating Sponsors, each of their respective franchisees, parents, affiliated companies, subsidiaries, distributors, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this contest (collectively, “Released Parties”), and the members of the immediate families or households, whether or not related, of any of the above. “Immediate family members” includes, for purposes of this promotion, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grand children (including step grand children) and each of their respective spouses, regardless of where they reside.
- (b) Individuals who do not have access to the internet as of 7/25/2016 in order to upload a photo submission for the Contest;

NOTE: Individuals age 13 to 17 may be eligible to participate in Contest with the approval of a parent or legal guardian, provided that the parent or legal guardian is a legal U.S. resident at least 18 years of age at the time of entry with a valid Social Security number and resides within the Cumulus radio station’s listening area. In the event of a winning submission, Parent/legal guardian will be required to accept prize on behalf of entrant, and must be one of the travelers, and must attend all activities/trip with minor.

How to Enter – Photo Submission: Select or create a photo (“selfie”) of your throwback class picture or any school photo or picture from the past, then upload or post your photo to enter the contest during the Registration and Photo Submission Period in any of the following four entry methods:

1. **Instagram Photo Post:** Access the Instagram application on your compatible mobile device. During the Registration and Photo Submission period, post the photo through your own public Instagram account with the hashtag **#SchoolPhotoSelfie**, along with any optional comments on the photo. **NOTE:** To enter the contest in this method, you must be an active holder of a non-private Instagram account (holders of private account settings may not enter in this method). If you do not have the Instagram application, you may download it through the application store on your mobile device. The Instagram application is free, and Instagram’s Terms of Use apply. For details, visit <http://instagram.com/legal/terms/>. Submitted photos will appear on Instagram under the hashtag **#SchoolPhotoSelfie**, along with being displayed on the contest website(s). If you enter using a mobile device on a wireless service provider’s network (as opposed to a Wi-Fi network), your carrier’s text and data rates will apply. You should consult your wireless service provider’s pricing plan for details. You agree to incur any and all charges demanded by your wireless carrier. All Instagram Photo Submission entries must be posted 11:59:59p ET on **9/4/2016** to be eligible.
2. **Twitter Photo Post:** Submit the photo via your own Twitter account, including a tweet of 140 characters or less from your mobile device or your computer using the hashtag **#SchoolPhotoSelfie**. If you wish to enter via Twitter and do not have a Twitter account, you may create one by visiting www.twitter.com. Twitter accounts are free, and Twitter’s Terms of Use apply. For details, visit <http://twitter.com/tos>. You must be an active holder of a nonprivate Twitter account to be eligible to enter this Contest via Twitter (i.e., you must make sure your tweets are set to “public” and not “private”). Submitted photos/tweets will appear on Twitter under the hashtag **#SchoolPhotoSelfie**, along with being displayed on the contest website(s). If you enter using a mobile device on a wireless service provider’s network (as opposed to a Wi-Fi network), your carrier’s text and data rates will apply. You should consult your wireless service provider’s pricing plan for details. You agree to incur any and

all charges demanded by your wireless carrier. All Twitter Photo Submission entries must be posted 11:59:59p ET on **9/4/2016** to be eligible.

3. **Facebook Photo Post:** Submit the Photo via your own public Facebook account, from your mobile device or your computer using the hashtag **#SchoolPhotoSelfie**. If you wish to enter via Facebook and do not have a Facebook account, you may create one by visiting www.facebook.com. Facebook accounts are free, and Facebook's Terms of Use apply. For details, visit <https://www.facebook.com/policies>. You must be an active holder of a non-private Facebook account to be eligible to enter this Contest via Facebook (i.e., you must make sure your photo posts are set to "public" and not "private"). Submitted Photos will appear on Facebook under the hashtag **#SchoolPhotoSelfie**. If you enter using a mobile device on a wireless service provider's network (as opposed to a Wi-Fi network), your carrier's text and data rates will apply. You should consult your wireless service provider's pricing plan for details. You agree to incur any and all charges demanded by your wireless carrier. All Facebook Photo entries must be posted by 11:59:59 pm PT on **9/4/2016** to be eligible.
4. **Direct Photo Upload – Online Entry:** During the contest Registration and Photo Submission Period, visit any participating Cumulus radio station website and click the banner ad to connect to the contest registration page, or visit the contest site directly at any of the following addresses (www.mdmgames.com/b2ssselfiemaddietae/, www.mdmgames.com/b2ssselfiehailee/, www.mdmgames.com/b2ssselfie/), and connect to the contest registration and photo upload/submission page. Follow the online instructions to upload your selected photo on the contest site and complete the online registration form with all required information including your name, valid email address, address (including city, state and zip), phone number (including area code), date of birth, and any optional comments about the photo. After having read and agreed to these Official Rules, click the submit button to submit your online photo submission and entry. Maximum photo file size may not exceed 5MB. All direct Photo upload entries must be uploaded and registration must be fully completed and submitted by 11:59:59p ET on **9/4/2016** to be eligible.

Maximum of one entry per person per day, regardless of method of entry. Each entry requires a unique photo that has not previously been entered in the contest. Each participant must submit an entry on his/her own behalf. Any entry submitted on behalf of another individual or using another person's name, email address or photo, or providing any false email addresses or information, will be disqualified and ineligible to claim any prize. Any attempt by any participant to obtain more than the stated number of entries allowed by using same, multiple/different emails, identities, or any other methods void that participant's entries and that participant may be disqualified. No mechanically produced or automated entries permitted. **Use of any automated system to participate is prohibited and will result in disqualification and all such entries will be deemed void. False and/or deceptive entries or acts, including misrepresentation of age, shall render such entries ineligible.**

All Photo Entries in the Contest become the sole property of Sponsor and will not be returned. Each Entrant agrees that their submitted Photo Entry may be viewed by the public. Sponsor reserves the right to disqualify and remove any Photo Entry at any time that is not in compliance with these Official Rules. All Photo Entries must conform to the photo submission requirements as outlined above and below, or it may be disqualified and not considered for the contest.

Any other individuals included in the Photo Entry, must provide Entrant with express consent and permission for their images to be included and submitted in the Contest, and such Entrant is solely responsible for obtaining all authorizations or approvals. The individual who submitted the Photo Entry shall be designated as the official Entrant competing in the Contest, regardless of any other individuals included in the Photo Entry, and shall be the only individual eligible for any resulting prize award (see below). Any Photo Entry completed and submitted on behalf of another individual or using another person's name, email address, or Instagram/Twitter account; or use of any unauthorized photo submissions will be disqualified.

By participating and submitting an entry, contestant agrees that Sponsor and participating parties are authorized to contact entrant via email, mail, phone or any other form of media to make contestant aware of information pertinent to the contest, and to distribute information regarding the Sponsor(s) featured products, discounts, special events or promotional offers. Contestants may opt-out of any further email communication at any time by simply replying REMOVE to any email message, or following the provided opt-out instructions. Any available opt-in opportunities are not required to enter the Contest, and checking the opt-in boxes will not improve your chances of winning.

All entries must include all required information. Any entry or photo submission with incorrect, incomplete or illegible information, an invalid email address or other inaccurate information will be disqualified. Released Parties are not responsible for lost, late, misdirected, incorrect, illegible, incomplete, invalid, unintelligible, or damaged entries, or for entries submitted in a manner that is not expressly allowed under these Official Rules, or for any entry not submitted or received due to any technical error or failure, human error, unauthorized human intervention, inaccurate capture or mis-entry of any required information, failures, omissions, interruptions, deletions, or defects of any phone or cellular phone provider, network computer online systems, computer equipment, servers, or software, including any injury or damage to contestant's or any other person's computer relating to or resulting from participation in this Contest; or the

failure to capture any such information or effects of hackers or failure of any electronic equipment, computer, phone line or cellular transmissions and/or network connections; all of which will be disqualified.

In the event of a dispute as to any entry, registration or submission, the authorized account holder of the e-mail address, Instagram, Twitter or Facebook account used to register or post the photo, and associated with the entry will be deemed to be the registrant and s/he must be eligible according to these Official Rules. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address or the assigned Instagram, Twitter or Facebook account holder of the account name used to post the photo. Proof of being the authorized account holder may be required.

By registering and submitting an entry and photo, you affirm that you have read and accepted these Official Rules. The laws of the United States apply to and govern this Contest and any claims must be raised and resolved in the United States. Any information collected by registering and entering the Contest shall be used only in a manner consistent with these Official Rules and with Sponsor's Privacy Policy. By entering the Contest, each contestant agrees that s/he may be contacted, recorded and/or broadcasted by Sponsor, and that his/her photo submission may be used, promoted, released, broadcasted or published by Sponsor in any manner related to the promotion or advertising of the Contest.

Collection and use of information collected in connection with the Contest will be in accordance with Contest Administrator's Privacy Policy as posted at www.mdmgames.com/b2ssselfiemaddietae/, www.mdmgames.com/b2ssselfiehailee/, and www.mdmgames.com/b2ssselfie/.

General Photo Submission Requirements:

- (a) Each photo must be submitted in a file format accepted by the Contest website, Instagram, Twitter or Facebook (i.e. Instagram App, JPG, PNG, etc);
- (b) Must be the Entrant's own original creation;
- (c) Include an image of a throwback class picture or any school picture from the past;
- (d) Any photo that is not properly submitted or received for any reason, including any technical difficulties, upload failures; failures to save or properly store the photo; busy signals, efforts of hackers; or any lost or disconnected internet connections, will be disqualified.

Additional Photo Submission Requirements: Sponsor reserves the right in its sole discretion, to disqualify any photo submission for any reason that it considers to not be appropriate for the Contest. Photo restrictions include, but are not limited to, the following requirements:

- not be, or ever have been, submitted in any competition or contest of any kind;
- not use any name, likeness, photograph, or any other identifying element, in whole or in part, of any person, living or dead, without permission;
- not be subject to any third party agreement or require payment or incurrence of any sums to obtain further permissions of any person or entity as a result of its use or exploitation of the idea or rights therein or portions, or modified versions or derivative works thereof;
- except as relates to the sponsoring brands or approved partners, not include trademarks, logos, or copyrighted material not owned by Entrant or material that is used without permission (including but not limited to company names, photographs, works of art, or images published on any media) or that otherwise infringes or violates the rights of any third party (including but not limited to, copyrights, trademarks, patents, trade secrets, logos, contract and licensing rights, rights of publicity or privacy, moral rights (i.e., "droit morale"), or any other intellectual property rights);
- not feature, refer to, or mention any radio stations, companies or brands in competition with Sponsor;
- not include any unauthorized photos or plagiarism of any kind;
- not be considered harmful to minors in any way;
- not contain nudity, inappropriate, indecent, sexually explicit, pornographic, or obscene content or images (which shall be determined by Sponsor, in its sole and absolute discretion);
- not contain any political or politically themed or motivated messages, statements, or images;
- not defame, slander, libel, misrepresent, or contain disparaging remarks or any other content that could adversely affect the name, reputation, or goodwill of Sponsor or any other individuals and/or entities affiliated or associated with Sponsor, the Contest, or any prizes, the determination of which shall remain in the sole discretion of Sponsor;
- not depict or include images that may be considered unlawful, harmful, threatening, violent, abusive, harassing, tortuous, defamatory, vulgar, libelous, invasive of another's privacy, hateful, or racially, religiously, ethnically or otherwise objectionable in any manner as solely determined by Sponsor;
- to the extent submitted through Instagram, adhere to the Instagram terms of use as set forth on the Instagram website at: <http://instagram.com/about/legal/terms/>;

Representation and Release of Rights to Photo Submissions: By submitting any photo, each contestant represents that s/he has sole and exclusive ownership and proprietary rights of all photo images submitted; has full permission of all parties within photo to publish and release their images and actions shown within the photo; and agrees that each photo becomes the sole and exclusive property of Sponsor, and Sponsor may publish, display, promote, or utilize photo in any manner of its choosing in relation to the promotion or advertising of the Contest or Sponsor. Entry into the Contest and upload of any photo, constitutes permission for the Sponsor and its designees to use that contestant's photo, name, city and state of residence and/or likeness for purposes of advertising and trade in any and all media now or hereafter known worldwide in perpetuity without limitation or further compensation, notification or permission, unless prohibited by law. Photo submissions will not be acknowledged or returned by Sponsor.

Sponsor reserves the right to request from any Entrant at any time proof, in a form acceptable to Sponsor, of any permission required or possibly required to use such Entrant's Photo Entry. Failure to provide such proof, if requested, may disqualify such Photo Entry from the Contest.

Sponsor reserves the right, in its sole discretion, to disqualify any individual (and all of his or her entries) who tampers or attempts to tamper with or abuse the entry process or the Contest website in any way or who is otherwise in violation of these Official Rules, as determined by Sponsor or the Contest judges appointed by Sponsor in their sole discretion. Any questions regarding the number of entries submitted or the authorized account holder shall be determined by Sponsor in its sole discretion. ANY ATTEMPT BY ANY PERSON TO DELIBERATELY DAMAGE ANY CONTEST WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO DISQUALIFY AND SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

Judging of Photo Submissions – Determination of Grand Prize Winners (maximum of two grand prize awards): An independent panel of judges as solely determined and appointed by Sponsor shall review, select and designate a maximum of two (2) grand prize winning photo submissions from among all eligible submissions received (see judging criteria below). One photo shall be selected to represent entries for "Maddie & Tae" submissions, and one photo shall be selected to represent entries for "Hailee Steinfeld" submissions. Each grand prize winner shall be selected from among all eligible photo submissions received as of 9/4/2016.

Each eligible contestant who submitted a selected photo submission shall be designated as a **potential winner** of the corresponding grand prize (see below) as designated by Sponsor, subject to verification of eligibility, and compliance with these Official Rules. Only the contestant whose photo submission is selected by the judges shall be eligible to claim the corresponding grand prize award. All other entries and photo submissions will be disqualified. If an insufficient number of eligible entries are received, then the corresponding grand prize shall not be awarded.

Photo submissions shall be judged by a Sponsor-appointed independent panel pursuant to the following guidelines, requirements and criteria in the determination of the winning photo submissions:

- Photo that are deemed to best depict a throwback class picture or any school photo or picture from the past, and that best represent the participating radio station(s), associated Sponsors, and Maddie & Tae or Hailee Steinfeld in a positive manner (50% of score);
- Creativity, originality, humor and/or other inspiration in the selection of the submitted photo (25% of score);
- Quality of the submitted photo (25% of score);

Prize Winner Selection & Notification (Maximum two grand prize winners): The potential grand prize winners will be notified initially by phone, email and/or message posting to the entrant's Instagram, Twitter or Facebook account beginning on or about 9/7/2016.

If the Administrator is unsuccessful in its attempt to reach and speak directly with a potential winner by phone within 24-hours of the initial notification attempt to the phone number, email address, Instagram, Twitter or Facebook account associated with that contestant's entry, then that contestant may be disqualified and an alternate potential prize winner may be randomly selected from among the remaining eligible entries and notified as per the procedures outlined above (*time permitting*). **Note: phone messages will not be left during the prize winner notification process.**

During prize winner notification, the selected potential winner must confirm their eligibility, and indicate their willingness and ability to accept the prize award and travel during the Sponsor designated travel dates. The potential winner will then receive official notification via mail or email delivery.

If the selected winner does not meet the eligibility requirements, is unable or unwilling to travel during the Sponsor designated travel dates, or elects to decline the prize, s/he will be disqualified and, at Sponsor's discretion and time permitting, an alternate winner will be randomly selected from among all remaining eligible entries and notified as per the procedures outlined above. Any disqualified contestant will not receive any alternate prize substitution or

compensation. **Decisions of the Administrator in the selection and determination of prize winner and all matters relating to this Contest are final and binding.**

All of the following will apply to the grand prize winner : 1) Winner will be required to complete and return, within 2-days of date of receipt, a prize acceptance form, a W-9 form (*if prize value exceeds \$600*), an affidavit of eligibility, and a liability/publicity release (where permitted); 2) Winner may be required to present a copy of a valid social security card and a valid driver's license as a condition of participating or receiving any prize; 3) Winner will be issued an IRS Form 1099 reflecting the actual value of all prizes won, if prize award value exceeds \$600; and 4) Winner will be responsible for paying all applicable taxes (including, but not limited to all local, state and federal taxes) on prize award. Failure to collect or properly claim any prize in accordance with these rules will result in forfeiture of the prize. If forfeited for any reason, winner will not receive any other prize substitution or compensation, and the prize will remain the property of Sponsor and will not be awarded, except as provided herein.

Actual departure date, times and airline based upon availability and will be solely determined by Sponsor, and all travel must be completed prior to 12/31/2016;
- Two (2)-nights standard hotel accommodations, double occupancy at a standard hotel as solely designated by Sponsor in the destination city metro area, based upon availability. Actual hotel location and reservation dates will be solely determined by sponsor;
- \$1,000 Gift Card to be used towards the Shopping Spree experience. Gift card issuer as solely determined by Sponsor (i.e. Visa, American Express, local Shopping mall, etc), and subject to the terms and conditions of the issuing gift card company.
- Opportunity for a private meet and greet with performers Maddie & Tae during trip, based upon schedule availability.

Grand Prize Award #2 (Hailee Steinfeld):

The Grand Prize #2 winner shall be awarded a Back to School Shopping Experience with Dustin Lynch, including:

- Round trip coach class airfare for two (winner and guest) from the gateway airport nearest to the winner's residence as designated by Sponsor in its sole discretion, to the nearest major airport servicing the designated destination city, as solely determined and designated by Sponsor (destination city to be determined based upon schedule availability). Actual departure date, times and airline based upon availability and will be solely determined by Sponsor, and all travel must be completed prior to 12/31/2016;
- Two (2)-nights standard hotel accommodations, double occupancy at a standard hotel as solely designated by Sponsor in the destination city metro area, based upon availability. Actual hotel location and reservation dates will be solely determined by sponsor;
- \$1,000 Gift Card to be used towards the Shopping Spree experience. Gift card issuer as solely determined by Sponsor (i.e. Visa, American Express, local Shopping mall, etc), and subject to the terms and conditions of the issuing gift card company.
- Opportunity for a private meet and greet with performer Hailee Steinfeld during trip, based upon schedule availability.

Maximum value of each grand prize not to exceed \$3,000. All other costs and expenses related to prize acceptance, redemption and use not specified herein as being provided are the sole responsibility of winner and guest, including but not limited to ground transportation, airport transfers, parking, travel or departure taxes, baggage check fees, airline seat assignment fees, hotel resort fees, meals, gratuities, any incidental expenses, and all applicable taxes (including, but not limited to all local, state and federal taxes). Each winner and guest are solely responsible for all costs incurred to and from the nearest major airport to the winner's home as designated by Sponsor as the prize originates and terminates at such departure point unless otherwise agreed to by Sponsor in writing. Sponsor not responsible for late, lost, damaged or stolen luggage.

Grand Prize winner's guest must be of legal age of majority in his/her state of residence, or grand prize winner must be legal parent or guardian of guest, and winner and guest will be required to execute and return a liability/publicity

release prior to prize award. It is recommended that each winner and guest obtain sufficient personal insurance prior to departure. Winner and guest hereby release Sponsor from any duty to provide, check, or verify any and all necessary travel identification, birth certificates, and any other travel or identification requirements ("Personal Documents"). Sponsor shall not have any responsibility for the replacement of lost or stolen Personal Documents or tickets, coupons, vouchers, receipts or other documents pertaining to the prize ("Travel Documents") once the Travel Documents have been provided to winner and guest.

Travel dates will be based upon availability, and are subject to change. Sponsor is not responsible for any flight cancellations, travel delays or difficulty. If travel delays or difficulty prevent arrival in time for any and all elements of trip, sponsor is not responsible for awarding any compensation in lieu thereof. Winner and his/her guest must travel together on the same itinerary. Any changes to completed travel arrangements, once booked, are the sole responsibility of the winner, and are solely at the winner's expense. Actual value of the trip will depend on point of departure, destination and any airfare fluctuations. If actual value of prize is lower than the stated maximum value of grand prize when prize is procured and fulfilled, then the difference will not be awarded to the winner.

Sponsor reserves the right to cancel and reschedule any opportunity for a meet and greet with the scheduled performer, substitute an alternate performer, or reschedule, relocate or cancel the meet and greet portion of the prize award, for any reason including but not limited to schedule conflicts, travel difficulties, or illness. If meet and greet opportunity is not available and must be cancelled for any reason, winner will forfeit that portion of prize award, and no alternate prize award or compensation shall be awarded.

All income, federal, state and local taxes are prize winner's sole responsibility. Prize award is non-transferable and no cash redemption or prize substitution allowed, except at Sponsor's sole discretion or as provided herein. Sponsor reserves the right to substitute a prize with one of comparable or greater value, at its sole discretion. Failure to collect or properly claim prize in accordance with these rules will result in forfeiture of the prize. All properly claimed prizes will be awarded. Any unclaimed prize will not be awarded.

Additional Rules & Restrictions: By participating, entrants agree to abide by and be bound by the Official Rules and the decisions of the Sponsor and Administrator, which shall be final in all matters relating to this Contest. In the event an entrant wins a prize, and is later found to be in violation of these rules he/she will be required to forfeit the prize or to reimburse Sponsor for the stated value of the prize if such violation is discovered after winner has used the prize.
