CUMULUS RADIO'S "A LITTLE MORE SUMMERTIME WITH JASON ALDEAN" SWEEPSTAKES OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of any of the participating radio stations set forth below (individually a "Station" and collectively, the "Stations"), owned and/or operated by Cumulus Media Holdings Inc. ("Sponsor") or one of its subsidiary companies during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to Sponsor at the address below.

Sponsor will conduct **Cumulus Radio's "A Little More Summertime with Jason Aldean" Sweepstakes** (the "Sweepstakes") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

2. Eligibility. This Sweepstakes is open only to legal U.S. residents who are age 21 or older at the time of entry with a valid Social Security number and who reside in the Designated Market Area ("DMA," as defined by Nielsen) of a Station. Send a text message to short code 64636, with the secret keyword that will be announced by tuning into one of the Stations in your DMA during the Sweepstakes Period. All entries must be received by 2:59 am ET on September 1, 2016 to be eligible for the grand prize drawing. Standard text messaging rates, as established by an individual's wireless carrier may apply, and Sponsor assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Sponsor. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other method will void that participant from further participation in the Sweepstakes. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected entries, all of which will be disqualified. In the event of a dispute as to any entry, the authorized account holder of the telephone number used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier. Potential winner may be required to show proof of being the authorized account holder. 5. Winner Selection. Failure to respond to the initial verification contact within 24 hours of notification will result in disqualification.

8. Entry Conditions and Release.
